The Washington State Recycling Association (WSRA) is a member supported organization whose mission is to provide leadership and education that fosters the expansion, diversity and economic vitality of recycling in support of sustainable resource management.

Conference/Trade Show: This annual, 4-day education program provides stakeholders in Washington's recycling industry with the knowledge, business connections and resources to address business and industry challenges, implement best practices, improve recycling programs, advocate for policies that advance recycling, and support the development of a generation of professionals for whom sustainability is a core tenet of their work and life philosophy.

4b (Code:) (Expenses \$ 7,380 including grants of \$) (Revenue \$ 21,255)

Washington Recycles Every Day (WRED) Program - This program is an annual series of four to five full-day educational events that include a speaker panel, three to five presentations, one to three facility tours, and time for networking to build business relationships and community partnerships vital to the expansion and economic vitality of the recycling industry. The objectives of this program are to engage recycling industry professionals in conversations that cut across sector and community; to provide opportunities for high-quality training and best practices from a diverse group of industry leaders consultants and other industry-critical topics; to inspire businesses, public agencies, schools and nonprofits around the state to start or expand their recycling and waste reduction programs, providing them with the contacts and resources that can help; and to inspire mid-level and entry-level staff and students to envision a career as leaders in the recycling and solid waste industry.

Professional Development Training - A two day professional development training focused on social marketing practices was offered. The course was an interactive training on the principals and application of social marketing for behavior change and was instructed by a leader in the social marketing field. Participants also were able to formulate a marketing plan for their own projects. This training was open to both membership of the organization and the public and participation was diverse among the public and private sectors.

Form 990, Part VI, Section B, Line 15 - Salaries of other executive directors of similar organizations are reviewed and used in determining the salary of WSRA's executive director. The same is done of additional staff positions in the organization.

Form 990, Part VI, Section C, Line 19 - WSRA made it's governing documents, conflict of interest policy, and financial statements available to the public during the tax year in its offices. Governing documents and abbreviated financial statements were also available on the organization's website.

Form 990, Part VIII, Line 8b - The associated expenses with the fundraising event income noted in Line 8a did not occur in this tax year and will fall in WSRA's 2017-2018 tax year.
